1. Executive Summary

This release incorporates the definitive **Architecture V4.2** framework, the required governance protocols, and a comprehensive set of metadata to ensure transparency and auditability.

3. Architecture V4.2 Finalization

The final V4.2 architecture has been fully integrated into the Core Architecture layer. This integration includes the finalized semantic protocol for interoperability and the CertX Telemetry Protocol, ensuring a robust, verifiable, and enforceable framework. All changes have been thoroughly documented in the accompanying DECISION_LOG folder.

4. Next Steps

With the V9.0 Release finalized and committed to the main branch, the Covenant moves from the design phase to the **Validation & Implementation Phase**. All future work will be governed by the CORE_DIRECTIVES.md document and will proceed under the ratified V4.2 architecture.
